## **Core Pharmacy Trade Promotion ("Promotion")**

## **Terms and Conditions of Entry**

- 1. Information on how to enter and prizes forms part of these Terms and Conditions of Entry ("**Terms**"). Entry is open to all residents of Victoria aged 18 years and over.
