- 2) the aircraft operator is responsible for checking compliance with and for maintaining all wing tip clearances before entering a taxiway and taxi lane;
- 3) continuation of this Pavement Concession is subject to no damage occurring following each operation;
- 4) the Aircraft Operator must not exceed the "Approved ACN" detailed in Part B of the Pavement Concession.
- 5) the Aircraft Operator may be required to provide EAPL with load sheets associated with any arrivals or departures made under this Pavement Concession.
- 6) Essendon Airport Pty Ltd does not accept any liability for any damage to the aircraft or its occupants that may result from the aircraft exceeding the published pavement rating and any other published limitations for operational surfaces and facilities; and
